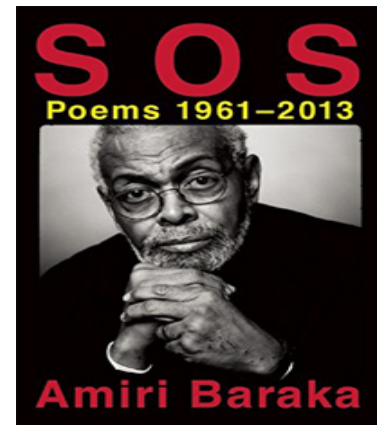

ADVERTISING SPECIFICATIONS FOR ELECTRONIC FILES

Please use only these files formats and specifications when sending advertising electronically.

For PDF documents: Make sure to embed all fonts (subset all below 100%) when distilling. Do not downsample artwork resolutions. Please set the distilled job options to compatibility with minimum Acrobat 6 version.

For Adobe InDesign Documents: Do not enlarge photos or other non-vector images more than 10% in Quark. Photos should be at 300 dpi line art at 1200 dpi. Include copies of all fonts used (printer and screen components, please), and make sure all graphics (TIFF, EPS or JPEG) are sent along with the Quark file. When e-mailing files, please make sure all document and accompanying files and fonts are included. EPS resolutions of images must be 300 dpi or greater.

You may also send ads as TIFF files, but make sure they look clear and smooth when output at 600 dpi.

When sending just photos, use TIFF or JPEG format. Photos should be at 300 dpi, line art at 1200 dpi.

Adobe InDesign, Illustrator, Photoshop and PDF Files are acceptable.

Proofs can include hard copy if mailed or delivered. The final proof will be e-mailed via PDF to customer to verify approval upon request.
